Available Grant:

Grants of up to \$3,000 are available to groups or organisations where there is appropriate involvement of fully registered members of the Pouakani Trust.

Charitable Purposes:

Pouakani Trust is a registered charitable trust and as such is restricted to providing grants and assistance for charitable purposes. Grant applications must meet one or more of the charitable purposes criteria as defined by the Act - "relief of poverty" or "beneficial to the community" or "advancement of education".

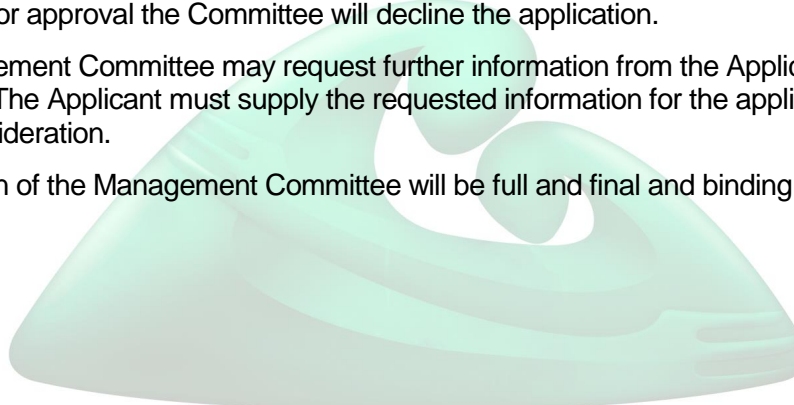
Criteria:

1. Applicants must be Whanau groups involving fully registered Pouakani Trust members.
2. Applicants are required to complete the 2 page application form in full.
3. Applicants are to provide a proposal of their event, a budget for their event and a list of participants.
4. The grant is to provide funding to assist group activities that will improve the well being of Trust members.

The criteria are subject to review and amendment from time to time by the Management Committee of the Pouakani Trust without notice to any person.

Process:

- Applications will be considered by the Management Committee of the Pouakani Trust.
- Applications may be approved in full or in part – at the sole discretion of the Management Committee and if approved subject to terms and conditions approved by the Committee in their sole discretion.
- If the Management Committee at their sole discretion are not satisfied that the application meets the criteria for approval the Committee will decline the application.
- The Management Committee may request further information from the Applicant before making a decision. The Applicant must supply the requested information for the application to receive further consideration.
- The decision of the Management Committee will be full and final and binding on the Applicant.
